Human sexual activity, human sexual practice or human sexual behaviour is the manner in which humans experience and express their sexuality. People engage - Human sexual activity, human sexual practice or human sexual behaviour is the manner in which humans experience and express their sexuality. People engage in a variety of sexual acts, ranging from activities done alone (e.g., masturbation) to acts with another person (e.g., sexual intercourse, non-penetrative sex, oral sex, etc.) or persons (e.g., orgy) in varying patterns of frequency, for a wide variety of reasons. Sexual activity usually results in sexual arousal and physiological changes in the aroused person, some of which are pronounced while others are more subtle. Sexual activity may also include conduct and activities which are intended to arouse the sexual interest of another or enhance the sex life of another, such as strategies to find or attract partners (courtship and display behaviour), or personal interactions between individuals (for instance, foreplay or BDSM). Sexual activity may follow sexual arousal.

Human sexual activity has sociological, cognitive, emotional, behavioural and biological aspects. It involves personal bonding, sharing emotions, the physiology of the reproductive system, sex drive, sexual intercourse, and sexual behaviour in all its forms.

In some cultures, sexual activity is considered acceptable only within marriage, while premarital and extramarital sex are taboo. Some sexual activities are illegal either universally or in some countries or subnational jurisdictions, while some are considered contrary to the norms of certain societies or cultures. Two examples that are criminal offences in most jurisdictions are sexual assault and sexual activity with a person below the local age of consent.

False pregnancy

women with false pregnancy. Endocrine changes observed in pseudocyesis include a decrease in dopamine levels, increase in nervous system activity, or dysfunction - False pregnancy (or pseudocyesis, from Ancient Greek *pseudes* 'false' and *kyesis* 'pregnancy') is the appearance of clinical or subclinical signs and symptoms associated with pregnancy although the individual is not physically carrying a fetus. The mistaken impression that one is pregnant includes signs and symptoms such as tender breasts with secretions, abdominal growth, delayed menstrual periods, and subjective feelings of a moving fetus. Examination, ultrasound, and pregnancy tests can be used to rule out false pregnancy.

False pregnancy has a prominent psychiatric component as well as physical manifestations of pregnancy. It can be caused by trauma (either physical or mental), a chemical imbalance of hormones, and some medical conditions. Contributing psychological factors include a strong desire for pregnancy or misinterpretation of objective bodily sensations. Although rare, men can experience false pregnancy symptoms, called Couvade syndrome or "sympathetic pregnancy", which can occur when their significant other is pregnant and dealing with pregnancy symptoms. Psychotherapy, pharmacotherapy with antidepressants or antipsychotics, hormonal therapy, and uterine curettage are sometimes needed as treatment.

While extremely rare in the United States because of the frequent use of medical imaging, in developing regions such as India and sub-Saharan Africa, the incidence of false pregnancy is higher. Rural areas see more instances of false pregnancy because such women are less often examined by a health care professional or midwife during the duration of believed pregnancy.

False killer whale

A false killer whale reaches physical - The false killer whale (*Pseudorca crassidens*) is a species of oceanic dolphin that is the only extant representative of the genus *Pseudorca*. It is found in oceans worldwide but mainly in tropical regions. It was first described in 1846 as a species of porpoise based on a skull, which was revised when the first carcasses were observed in 1861. The name "false killer whale" comes from having a skull similar to the orca (*Orcinus orca*), or killer whale.

The false killer whale reaches a maximum length of 6 m (20 ft), though size can vary around the world. It is highly sociable, known to form pods of up to 50 members, and can also form pods with other dolphin species, such as the common bottlenose dolphin (*Tursiops truncatus*). It can form close bonds with other species, as well as have sexual interactions with them. But the false killer whale has also been known to eat other dolphins, though it typically eats squid and fish. It is a deep-diver; maximum known depth is 927.5 m (3,043 ft); maximum speed is around 29 km/h (18 mph).

Several aquariums around the world keep one or more false killer whales, though its aggression toward other dolphins makes it less desirable. It is threatened by fishing operations, as it can entangle in fishing gear. It is drive hunted in some Japanese villages. The false killer whale has a tendency to mass-strand given its highly social nature; the largest stranding consisted of over 800 beached at Mar del Plata, Argentina, in 1946. Most of what is known of this species comes from examining stranded individuals.

False flag

Similarly deceptive activities carried out during peacetime by individuals or nongovernmental organizations have been called false-flag operations, but - A false flag operation is an act committed with the intent of disguising the actual source of responsibility and pinning blame on another party. The term "false flag" originated in the 16th century as an expression meaning an intentional misrepresentation of someone's allegiance. The term was originally used to describe a ruse in naval warfare whereby a vessel flew the flag of a neutral or enemy country to hide its true identity. The tactic was initially used by pirates and privateers to deceive other ships into allowing them to move closer before attacking them. It later was deemed an acceptable practice during naval warfare according to international maritime laws, provided the attacking vessel displayed its true flag before commencing an attack.

The term today extends to include countries that organize attacks on themselves and make the attacks appear to be by enemy nations or terrorists, thus giving the nation that was supposedly attacked a pretext for domestic repression or foreign military aggression (as well as to engender sympathy). Similarly deceptive activities carried out during peacetime by individuals or nongovernmental organizations have been called false-flag operations, but the more common legal term is a "frameup", "stitch up", or "setup".

False imprisonment

individual has been, is, or is about to be engaged in a criminal activity. To prevail under a false imprisonment claim, a plaintiff must prove: Willful detention - False imprisonment or unlawful imprisonment occurs when a person intentionally restricts another person's movement within any area without legal authority, justification, or the restrained person's permission.

Actual physical restraint is not necessary for false imprisonment to occur. A false imprisonment claim may be made based upon private acts, or upon wrongful governmental detention.

For detention by the police, proof of false imprisonment provides a basis to obtain a writ of habeas corpus.

Under common law, false imprisonment is both a crime and a tort.

False Dmitry II

False Dmitry II (Russian: ????????? II, romanized: Lzhedmitrii II; died 21 December [O.S. 11 December] 1610), historically known as Pseudo-Demetrius - False Dmitry II (Russian: ????????? II, romanized: Lzhedmitrii II; died 21 December [O.S. 11 December] 1610), historically known as Pseudo-Demetrius II and also called tushinsky vor ("the thief of Tushino"), was the second of three pretenders to the Russian throne who claimed to be Tsarevich Dmitry Ivanovich, the youngest son of Ivan the Terrible, during the Time of Troubles. The real Dmitry had died under uncertain circumstances, most likely an assassination in 1591 at the age of nine at his widowed mother's appanage residence in Uglich.

The second False Dmitry first appeared on the scene around 20 July 1607, at Starodub. He is believed to have been either a priest's son or a converted Jew, and was relatively highly educated for the time. He spoke both the Russian and Polish languages and was something of an expert in liturgical matters. He pretended at first to be the Muscovite boyar Nagoy, but falsely confessed under torture that he was Tsarevich Dmitry, whereupon he was taken at his word and joined by thousands of Cossacks, Poles, and Muscovites.

Dunning states, "According tradition, the future 'Tsar Dmitry' was at the time of his 'discovery' a priest's servant and teacher who lived for some time in the town of Shklov in Belorussia." In the winter of 1606-7, unemployed and reduced to begging, Pan Miechowicki noticed the beggar looked similar to Dmitry, and eventually convinced the beggar to learn the role of the deceased prince. In May 1607, accompanied by two aides, the impostor crossed the border and made his way to Starodub.

In 1608, following a peace agreement with King Sigismund, Tsar Vasili agreed to release the father-in-law of False Dmitry I, Jerzy Mniszech, and his widow, Marina Mniszech. They soon joined the second false Dmitry's camp in Tushino, where she "recognized" her late husband in this second Dmitry. According to Dunning, "On the Tushino impostor's boyar council sat such powerful men as Mikhail G. Saltykov and Dmitrii Trubetskoi. They were soon joined by several of Tsar Dmitry's former courtiers, including Grigorii Shakhovskoi and Mikhail Molchanov. The Saltykov and Romanov families were by far the most influential Russians in Tushino. The arrival in Tushino of Jan Piotr Sapieha with seven thousand cavalymen in August sped up rebel military activity."

He quickly captured Karachev, Bryansk, and other towns, was reinforced by the Poles, and in the spring of 1608 advanced upon Moscow, routing the army of Tsar Vasili Shuisky at Bolkhov. Promises of wholesale confiscation of the estates of the boyars drew many common people to his side. The village of Tushino, twelve versts from the capital, was converted into an armed camp where Dmitry gathered his army. His force initially included 7,000 Polish soldiers, 10,000 Cossacks and 10,000 other rag-tag soldiers, including former members of the failed Zebrzydowski Rebellion. His forces soon exceeded 100,000 men. He raised to the rank of patriarch another illustrious captive, Philaret Romanov, and won the allegiance of the cities of Yaroslavl, Kostroma, Vologda, Kashin and several others.

The arrival of King Sigismund III Vasa at Smolensk caused a majority of his Polish supporters to desert him and join with the armies of the Polish king. At the same time, a strong Russo-Swedish army under Mikhail Skopin-Shuisky and Jacob De la Gardie approached Tushino, forcing him to flee his camp disguised as a peasant and go to Kostroma, where Marina joined him and he lived once more in regal state. He made

another unsuccessful attack on Moscow, and, supported by the Don Cossacks, recovered a hold over all south-eastern Russia. However, he was killed, while half drunk, on 11 December 1610 by a Tatar princeling, Peter Urusov, whom he had flogged. Hetman Stanisław Żółkiewski described this event in his memoirs:

Having drunk deep at dinner... he ordered a sleigh to be harnessed, taking flasks of mead to the sleigh. Coming out into the open country, he drank with some boyars. Prince Peter Urusov, together with those several score horsemen with whom he was in league, was riding after him, apparently escorting him. And when the imposter had drunk very well with the boyars, Urusov drew from his holster a pistol which he had ready, and galloping up to the sleigh first shot him with the pistol, then cutting off his head and hand with his saber, took to the road.

False consciousness

a social class acquires through their life activities in capitalist society." Lukács didn't regard false consciousness as a static condition but rather - In Marxist theory, false consciousness is a term describing the ways in which material, ideological, and institutional processes are said to mislead members of the proletariat and other class actors within capitalist societies, concealing the exploitation and inequality intrinsic to the social relations between classes. As such, it legitimizes and normalizes the existence of different social classes.

According to Marxists, false consciousness is consciousness which is misaligned from reality. Thus, it is a serious impediment to human progress and correcting it is a major focus of dialectical materialism.

False or misleading statements by Donald Trump

has made tens of thousands of false or misleading claims. Fact-checkers at The Washington Post documented 30,573 false or misleading claims during his - During and between his terms as President of the United States, Donald Trump has made tens of thousands of false or misleading claims. Fact-checkers at The Washington Post documented 30,573 false or misleading claims during his first presidential term, an average of 21 per day. The Toronto Star tallied 5,276 false claims from January 2017 to June 2019, an average of six per day. Commentators and fact-checkers have described Trump's lying as unprecedented in American politics, and the consistency of falsehoods as a distinctive part of his business and political identities. Scholarly analysis of Trump's X posts found significant evidence of an intent to deceive.

Many news organizations initially resisted describing Trump's falsehoods as lies, but began to do so by June 2019. The Washington Post said his frequent repetition of claims he knew to be false amounted to a campaign based on disinformation. Steve Bannon, Trump's 2016 presidential campaign CEO and chief strategist during the first seven months of Trump's first presidency, said that the press, rather than Democrats, was Trump's primary adversary and "the way to deal with them is to flood the zone with shit." In February 2025, a public relations CEO stated that the "flood the zone" tactic (also known as the firehose of falsehood) was designed to make sure no single action or event stands out above the rest by having them occur at a rapid pace, thus preventing the public from keeping up and preventing controversy or outrage over a specific action or event.

As part of their attempts to overturn the 2020 U.S. presidential election, Trump and his allies repeatedly falsely claimed there had been massive election fraud and that Trump had won the election. Their effort was characterized by some as an implementation of Hitler's "big lie" propaganda technique. In June 2023, a criminal grand jury indicted Trump on one count of making "false statements and representations", specifically by hiding subpoenaed classified documents from his own attorney who was trying to find and return them to the government. In August 2023, 21 of Trump's falsehoods about the 2020 election were listed

in his Washington, D.C. criminal indictment, and 27 were listed in his Georgia criminal indictment. It has been suggested that Trump's false statements amount to bullshit rather than lies.

False awakening

theory states that false awakening is shaped on some fixed patterns depicting real activities, especially the day-to-day routine. False awakening is often - A false awakening is a vivid and convincing occurrence in a dream where one experiences awakening from sleep, though in reality continues to sleep. It is mostly associated with another dream, however it may occur as its own. After a false awakening, subjects often dream they are performing their daily morning routine such as showering or eating breakfast. False awakenings, mainly those in which one dreams that they have awoken from a sleep that featured dreams, take on aspects of a double dream or a dream within a dream. A classic example in fiction is the double false awakening of the protagonist in Gogol's Portrait (1835).

Studies have shown that false awakening is closely related to lucid dreaming that often transforms into one another. The only differentiating feature between them is that the dreamer has a logical understanding of the dream in a lucid dream, while that is not the case in a false awakening.

Once one realizes they are falsely awakened, they either wake up or begin lucid dreaming.

False color

False colors and pseudo colors respectively refers to a group of color rendering methods used to display images in colors which were recorded in the visible - False colors and pseudo colors respectively refers to a group of color rendering methods used to display images in colors which were recorded in the visible or non-visible parts of the electromagnetic spectrum. A false-color image is an image that depicts an object in colors that differ from those a photograph (a true-color image) would show. In this image, colors have been assigned to three different wavelengths that human eyes cannot normally see.

In addition, variants of false colors such as pseudocolors, density slicing, and choropleths are used for information visualization of either data gathered by a single grayscale channel or data not depicting parts of the electromagnetic spectrum (e.g. elevation in relief maps or tissue types in magnetic resonance imaging).
