The law and the gospel. A course of plain sermons on the Ten commandments

This is a critical handbook on T. S. Eliot's poetical works and verse dramas with their text and critical interpretation for students of Asian and African countries. An exhaustive discussion is made through critical analysis of Eliot's literary personality as a poet and theorist. Eliot exercised a strong influence on Anglo-American culture from the 1920s until late in the century. His experiments in diction, style, and versification revitalized English poetry, and in a series of critical essays, he shattered old orthodoxies and erected new ones. The publication of *Four Quartets* led to his recognition as the greatest living English poet and man of letters, and in 1948 he was awarded both the Order of Merit and the Nobel Prize for Literature. Eliot was to pursue four careers: editor, dramatist, literary critic, and philosophical poet. He was probably the most erudite poet of his time in the English language. His undergraduate poems were "literary" and conventional. His first important publication, and the first masterpiece of Modernism in English, was "The Love Song of J. Alfred Prufrock". The poem "The Waste Land" is known for its obscure nature—its slippage between satire and prophecy; its abrupt changes of speaker, location, and time. Eliot's concern with faith and doubt, chaos and calamity and decline in the sensibility of the modern people is reflected through his poems and plays. Modernity and the sense for the modernist make him unparalleled and the most popular modern poet. His great musical sense in his poetry reminds of his use of rhymes, metre and rhythm. This rimming of poetry with music brings meaningful beauty and concept.

Prostitution and Eighteenth-Century Culture

The voluminous writings of Ludwig Wittgenstein contain some of the most profound reflections of recent times on the nature of the human subject and self-understanding - the human condition, philosophically speaking. The chapters take up in turn the topics of self-consciousness, what Wittgenstein calls 'the inner picture', mental privacy and the picture of metaphysical seclusion, the very idea of our observation of the contents of consciousness, first-person expressive speech, reflexive or self-directed thought and competing pictures of introspection, the nuances of retrospective self-understanding, person-perception and the corollary issues of self-perception (itself an interestingly dangerous phrase), self-defining memory, and the therapeutic conception of philosophical progress as it applies to all of these issues. The cast of characters interwoven throughout this rich discussion include, in addition to Wittgenstein centrally, Augustine, Goethe, Dostoevsky, Kierkegaard, Iris Murdoch, Donald Davidson, and Stanley Cavell, among others. Throughout, conceptual clarifications concerning mind and language are put to work in the investigation of issues relating to self-description and in novel philosophical readings of autobiographical texts.

Poetics and Literary Theory of T. S. Eliot

Is non-violence oppressive? This book argues that non-violent ethics keeps minoritized peoples down and helps the bourgeoisie tolerate structural injustice. Like sex, violence needs de-moralizing, in order to fulfil its emancipatory potential. Social injustice and global inequality will not deprive the privileged of their sleep, if radical measures are morally ruled out from the start. And the ethics of non-violence robs the working classes of one of the few mechanisms they have left to help them cope with our increasingly digitalized bureaucracies, developed around the needs of highly educated urban classes. There is not just the normative obvious point that it is not fair to deprive the oppressed of one of the only resources they have left; it is also that it isn't surprising that the bourgeoisie would settle on a non-violent ethics, since that happens to prop up their privileged position – while at the same time soothing their precious conscience: capital with a soul. The book defends three overall claims: first, non-violence is oppressive, in the traditional feminist sense of keeping people down; second, non-violence helps the bourgeoisie tolerate structural injustice; and thirdly, that access to violent means is not distributed fairly across gender or race, for example.

Describing Ourselves

The aim of this book is to outline a general theory of hope, to explore its structure, forms, goals, reasonableness, and implications, and to trace the implications of such a theory for atheism or theism. It offers a systematic analysis, but one worked out in dialogue with Ernst Bloch, Immanuel Kant, and Gabriel Marcel.
