On June 25, 2009, the American singer Michael Jackson died of acute propofol intoxication in Los Angeles, California, at the age of 50. His personal physician, Conrad Murray, said that he found Jackson in his bedroom at his North Carolwood Drive home in the Holmby Hills area of the city not breathing and with a weak pulse; he administered cardiopulmonary resuscitation (CPR) to no avail, and security called 9-1-1 at 12:21 p.m. Pacific Daylight Time (UTC−7). Paramedics treated Jackson at the scene, but he was pronounced dead at the Ronald Reagan UCLA Medical Center in Westwood at 2:26 p.m.

On August 28, 2009, the Los Angeles County Department of Medical Examiner concluded that Jackson's death was a homicide. Jackson had been administered propofol and anti-anxiety benzodiazepines lorazepam and midazolam by his doctor. Murray was convicted of involuntary manslaughter in November 2011, and was released in 2013 after serving two years of his four-year prison sentence with time off for good behavior.

At the time of his death, Jackson had been preparing for a series of comeback concerts, *This Is It*, that were due to begin in July 2009 in London, United Kingdom. Following his death there were unprecedented surges of Internet traffic and a spike in sales of his music. A televised memorial service, held at the Staples Center (later renamed to Crypto.com Arena) in Los Angeles, had an estimated 2.5 billion viewers. In 2010, Sony Music Entertainment signed a US\$250 million deal with Jackson's estate to retain distribution rights to his recordings until 2017 and to release seven posthumous albums of unreleased material over the following decade, but only two were ever released.

The song was not performed by Jackson on any of his tours. He did, however, perform a small segment of the song in his interview with Oprah Winfrey in early 1993.

Trial of Michael Jackson

Jackson* (full title: 1133603: The People of the State of California v. Michael Joe Jackson) was a 2005 criminal trial held in Santa Barbara County Superior Court in Santa Maria, California. The American pop singer Michael Jackson was charged with molesting Gavin Arvizo, who was 13 years old at the time of the alleged abuse, at his Neverland Ranch estate in Los Olivos, California.

Jackson was first accused of child sexual abuse in 1993; he denied the allegations and settled in a civil lawsuit. In 2003, the documentary *Living with Michael Jackson* showed Jackson holding hands with Arvizo and defending his practice of giving his bed to children, triggering an investigation. Jackson was indicted on four counts of molesting a minor, four counts of intoxicating a minor to molest him, one count of attempted child molestation, one count of conspiring to hold the Arvizo family captive, and conspiring to commit extortion and child abduction.

The trial spanned approximately four months, beginning with jury selection that began on January 31, 2005. Gavin and his brother testified that Jackson had given them alcohol, showed them pornography, masturbated before them, and made sexual advances. The defense characterized the witnesses for the prosecution as disgruntled ex-employees or individuals seeking to exploit Jackson for money. Witnesses for the defense included testimony from celebrities including the former child actor Macaulay Culkin and the comedian Chris Tucker. Coverage of the trial was described as a media circus, and many media outlets were quick to portray Jackson as guilty.

Jackson was acquitted on all counts on June 13, 2005. He never returned to Neverland Ranch, and spent the first several months after the trial living abroad in Bahrain and Ireland. In 2013, four years after Jackson's death, one of the defense witnesses, Wade Robson, changed his position and filed a lawsuit, saying he had been abused by Jackson.

Health and appearance of Michael Jackson

From the mid-1980s, Jackson's appearance began to change dramatically. The changes to his face triggered widespread speculation of extensive cosmetic surgery, and his skin tone became much lighter.

Jackson was diagnosed with the skin disorder vitiligo, which results in white patches on the skin and sensitivity to sunlight. To treat the condition, he used fair-colored makeup and skin-lightening prescription creams to cover up the uneven blotches of color caused by the illness. The creams would have further lightened his skin. The lighter skin resulted in criticism that he was trying to appear white. Jackson said he had not purposely bleached his skin and that he was not trying to be anything he was not.

Jackson and some of his siblings said they had been physically and psychologically abused by their father Joe Jackson. In 2003, Joe admitted to whipping them as children, but he emphatically rejected the longstanding

abuse allegations. The whippings deeply traumatized Jackson and may have led to the onset of further health problems later in his life. Physicians speculated that he had body dysmorphic disorder.

At some point during the 1990s, it appeared that Jackson had become dependent on prescription drugs, mainly painkillers and strong sedatives. The drug use was later linked to second- and third-degree burns he had suffered years before. Jackson gradually became dependent on these drugs, and his health deteriorated. He went into rehabilitation in 1993. While preparing for a series of comeback concerts scheduled to begin in July 2009, Jackson died of acute propofol and benzodiazepine intoxication after suffering cardiac arrest on June 25, 2009. His personal physician was convicted of involuntary manslaughter in his death and sentenced to four years in prison.

Michael Jackson

Michael Joseph Jackson (August 29, 1958 – June 25, 2009) was an American singer, songwriter, dancer, and philanthropist. Dubbed the "King of Pop", he is widely regarded as one of the most culturally significant figures of the 20th century. Over a four-decade career, his music achievements broke racial barriers in America and made him a dominant figure worldwide. Through his songs, stages, and fashion, he proliferated visual performance for artists in popular music, popularizing street dance moves such as the moonwalk, the robot and the anti-gravity lean. Jackson is often deemed the greatest entertainer of all time based on his acclaim and records.

The eighth child of the Jackson family, Michael made his public debut at age six as the lead singer of the Jackson 5 (later known as the Jacksons), one of Motown's most successful acts. His breakthrough as a solo artist came with the disco-inspired album *Off the Wall* (1979). Jackson achieved unprecedented global success with *Thriller* (1982), the best-selling album in history. Its short film-style music videos for the title track, "Beat It", and "Billie Jean" popularized MTV and redefined music videos as an art form. He followed it with *Bad* (1987), the first album to produce five US Billboard Hot 100 number-one singles: "I Just Can't Stop Loving You", "Bad", "The Way You Make Me Feel", "Man in the Mirror", and "Dirty Diana". *Dangerous* (1991) and *HIStory* (1995) explored social themes, and *Invincible* (2001) delved into personal themes.

From the late 1980s, Jackson became a figure of controversy and speculation due to his changing appearance, relationships, behavior, and lifestyle. He was accused of sexually abusing the child of a family friend in 1993. In 2005, Jackson was tried and acquitted of further child sexual abuse allegations and all other charges. While preparing for a series of comeback concerts, he died in 2009 from an overdose of propofol administered by his personal physician Conrad Murray, who was convicted in 2011 of involuntary manslaughter. Jackson's death triggered reactions around the world, creating unprecedented surges of internet traffic and a spike in sales of his music. His televised memorial service, held at the Staples Center in Los Angeles, was estimated to have been viewed by more than 2.5 billion people.

Jackson is one of the best-selling music artists of all time, with estimated sales of over 500 million records worldwide. He has 13 Billboard Hot 100 number-one singles, a joint-record for a male solo artist and is the first artist to have a top-ten single on the chart in five different decades. Jackson was inducted into the Rock and Roll Hall of Fame twice, the National Rhythm & Blues Hall of Fame, the Vocal Group Hall of Fame, the Songwriters Hall of Fame and the Dance Hall of Fame. One of the most-awarded artists in popular music, his accolades include 13 Grammy Awards, the Grammy Legend Award, and the Grammy Lifetime Achievement Award; 26 American Music Awards, including Artist of the Century; 12 World Music Awards; six Brit Awards; the Bambi Pop Artist of the Millennium Award and three presidential honors. As a philanthropist, Jackson donated an estimated \$500 million to charity throughout his lifetime. In 2024, half of his music

catalogue sold to Sony for \$600 million, the largest music acquisition for a single artist in history.

Estate of Michael Jackson

The estate of Michael Jackson is a legal entity established following the death of American singer Michael Jackson on June 25, 2009 for the purpose of - The estate of Michael Jackson is a legal entity established following the death of American singer Michael Jackson on June 25, 2009 for the purpose of administering his property and overseeing his posthumous income. Jackson's last will was filed by the attorney John Branca at the Los Angeles County courthouse on July 1, 2009. Signed July 7, 2002, it names Branca and accountant John McClain as executors; they were confirmed as such by a Los Angeles judge on July 6, 2009. All assets are given to the (pre-existing) Michael Jackson Family Trust (amended March 22, 2002), the details of which have not been made public. The Associated Press reported that, in 2007, Jackson had a net worth of \$236.6 million: \$567.6 million in assets, which included Neverland Ranch and his 50% share of Sony/ATV Music Publishing' catalogue, and debts of \$331 million. The guardianship of his three children is given to his mother, Katherine, or if she is unable or unwilling, to singer Diana Ross. Jackson's will allocates 20% of his fortune as well as 20% of money made after death to unspecified charities.

In 2012, in an attempt to end a family dispute, Jackson's brother Jermaine retracted his signature on a public letter criticizing executors of Jackson's estate and his mother's advisers over the legitimacy of his brother's will. T.J. Jackson, son of Tito Jackson, was given co-guardianship of Michael Jackson's children after false reports of Katherine Jackson going missing. Media reports suggested that the settlement of Jackson's estate could last many years. The value of Sony/ATV Music Publishing is estimated to be US\$1.5 billion. The estimate makes Jackson's share of Sony/ATV worth \$750 million, from which Jackson would have had an annual income of \$80 million. In September 2016, a deal was finalized for Sony's acquisition of Jackson's share of Sony/ATV from the Jackson estate for \$750 million.

In 2016, Jackson's estate earned \$825 million, the highest yearly amount for a celebrity ever recorded by Forbes. In July 2018, Sony/ATV bought out the Jackson estate's 10% stake in EMI for \$287.5 million.

1993 Michael Jackson sexual abuse allegations

American singer Michael Jackson first faced allegations of child sexual abuse in 1993. Evan Chandler, a dentist and screenwriter based in Los Angeles, accused Jackson of sexually abusing Chandler's 13-year-old son, Jordan. Jackson had befriended Jordan after renting a vehicle from Jordan's stepfather. Though Evan initially encouraged the friendship, he confronted his ex-wife, who had custody of Jordan, with suspicions that the relationship was inappropriate.

Chandler demanded money from Jackson, threatening to go to a criminal court, but no agreement was reached. After Jordan told a psychiatrist that Jackson had molested him, the Los Angeles Police Department began a criminal investigation. The investigation found no physical evidence against Jackson.

In August 1993, as the second leg of Jackson's Dangerous World Tour began, news of the allegations broke and received worldwide media attention. Jackson canceled the remainder of the tour, citing health problems arising from the scandal. Jackson's sister La Toya Jackson said Jackson was a pedophile, but produced no evidence and withdrew the accusation, saying she had been forced to make it by her husband.

In September 1993, the Chandlers filed a lawsuit against Jackson. They and Jackson reached a financial settlement in January 1994; Jackson and his legal team stressed that this was not an admission of guilt. In September 1994, the investigation closed after the Chandlers declined to cooperate, leaving the case without its main witness.

The allegations damaged Jackson's public image, health, and commercial standing. Several of his endorsement deals were canceled, including his decade-long Pepsi endorsement. Further allegations of abuse by Jackson led to the People v. Jackson trial in 2005, in which Jackson was acquitted.
