## Hillary Clinton

Hillary Diane Rodham Clinton (née Rodham; born October 26, 1947) is an American politician, lawyer and diplomat. She was the 67th United States secretary - Hillary Diane Rodham Clinton (née Rodham; born October 26, 1947) is an American politician, lawyer and diplomat. She was the 67th United States secretary of state in the administration of Barack Obama from 2009 to 2013, a U.S. senator representing New York from 2001 to 2009, and the first lady of the United States as the wife of Bill Clinton from 1993 to 2001. A member of the Democratic Party, she was the party's nominee in the 2016 presidential election, becoming the first woman to win a presidential nomination by a major U.S. political party and the only woman to win the popular vote for U.S. president. However, she lost the electoral college to Republican Party nominee Donald Trump. She is the only first lady of the United States to have run for elected office.

Born in Chicago, Rodham graduated from Wellesley College in 1969 and from Yale Law School in 1973. After serving as a congressional legal counsel, she moved to Arkansas and, in 1975, married Bill Clinton. In 1977, Clinton co-founded Arkansas Advocates for Children and Families, and in 1979 she became the first woman partner at Little Rock's Rose Law Firm. Clinton was the first lady of Arkansas from 1979 to 1981 and again from 1983 to 1992. As the first lady of the U.S., Clinton advocated for healthcare reform. In 1994, her health care plan failed to gain approval from Congress. In 1997 and 1999, Clinton played a leading role in promoting the creation of the State Children's Health Insurance Program, the Adoption and Safe Families Act, and the Foster Care Independence Act. In 1998, Clinton's marital relationship came under public scrutiny during the Clinton–Lewinsky scandal, which led her to publicly reaffirm her commitment to the marriage.

Clinton was first elected to the U.S. Senate in 2000, becoming the first female senator from New York. As a senator, she chaired the Senate Democratic Steering and Outreach Committee from 2003 to 2007. Clinton ran for president in 2008, but lost to Barack Obama in the Democratic primaries. In 2009, she resigned from the Senate to become Obama's secretary of state. She responded to the Arab Spring by advocating the 2011 military intervention in Libya, but was harshly criticized by Republicans for the failure to prevent or adequately respond to the 2012 Benghazi attack. Clinton helped to organize a regime of international sanctions against Iran in an effort to force it to curtail its nuclear program, which eventually led to the multinational Joint Comprehensive Plan of Action in 2015. The strategic pivot to Asia was a central aspect of her tenure. Her use of a private email server as secretary was the subject of intense scrutiny; while no charges were filed, the controversy was the single-most-covered topic during her second presidential run in 2016. She won the Democratic nomination, but lost the general election to her Republican Party opponent, Donald Trump, in the Electoral College, while winning the popular vote.

Following her loss, she wrote multiple books and launched Onward Together, a political action organization dedicated to fundraising for progressive political groups. In 2011, Clinton was appointed the Honorary Founding Chair of the Institute for Women, Peace and Security at Georgetown University, and the awards named in her name has been awarded annually at the university. Since 2020, she has served as Chancellor of Queen's University Belfast. In 2023, Clinton joined Columbia University as a Professor of Practice at the School of International and Public Affairs.

## Hillary Clinton email controversy

During her tenure as the United States secretary of state, Hillary Clinton drew controversy by using a private email server for official public communications - During her tenure as the United States secretary of state, Hillary Clinton drew controversy by using a private email server for official public communications rather than using official State Department email accounts maintained on federal servers. After a years-long FBI investigation, it was determined that Clinton's server did not contain any information or emails that were clearly marked classified. Federal agencies did, however, retrospectively determine that 100 emails contained information that should have been deemed classified at the time they were sent, including 65 emails deemed "Secret" and 22 deemed "Top Secret". An additional 2,093 emails were retroactively designated confidential by the State Department.

"From the group of 30,000 e-mails returned to the State Department, 110 e-mails in 52 e-mail chains have been determined by the owning agency to contain classified information at the time they were sent or received. Eight of those chains contained information that was Top Secret at the time they were sent; 36 chains contained Secret information at the time; and eight contained Confidential information, which is the lowest level of classification." "Separately, it is important to say something about the marking of classified information. Only a very small number of the e-mails containing classified information bore markings indicating the presence of classified information."

Some experts, officials, and members of Congress contended that Clinton's use of a private email system and a private server violated federal law, specifically 18 U.S. Code § 793e, regarding the unauthorized removal and retention of classified documents or materials, as well as State Department protocols and procedures, and regulations governing recordkeeping. Clinton claimed that her use complied with federal laws and State Department regulations, and that former secretaries of state had also maintained personal email accounts (however Clinton was the only secretary of state to use a private server). News reports by NBC and CNN indicated that the emails discussed "innocuous" matters that were already public knowledge.

The controversy was a major point of discussion and contention during the 2016 presidential election, in which Clinton was the Democratic nominee. In May, the State Department's Office of the Inspector General released a report about the State Department's email practices, including Clinton's. In July, FBI director James Comey announced that the FBI investigation had concluded that Clinton had been "extremely careless" but recommended that no charges be filed because Clinton did not act with criminal intent, the historical standard for pursuing prosecution.

On October 28, 2016, eleven days before the election, Comey notified Congress that the FBI had started looking into newly discovered emails. On November 6, Comey notified Congress that the FBI had not changed its conclusion. Comey's timing was contentious, with critics saying that he had violated Department of Justice guidelines and precedent, and prejudiced the public against Clinton. The controversy received more media coverage than any other topic during the presidential campaign. Clinton and other observers like Nate Silver, Ezra Klein and Vox argue that the reopening of the investigation was the main reason for her loss in the election. Comey said in his 2018 book *A Higher Loyalty* that his decision may have been unconsciously influenced by the fact that he considered it extremely likely that Clinton would become the next president.

On June 14, 2018, the Department of Justice's Office of the Inspector General released its report on the FBI's and DOJ's handling of Clinton's investigation, finding no evidence of political bias and lending support for the decision to not prosecute Clinton. A three-year State Department investigation concluded in September 2019 that 38 individuals were "culpable" in 91 instances of sending classified information that reached Clinton's email account, though it found "no persuasive evidence of systemic, deliberate mishandling of classified information". Yet a September 2022 "Fact Checker" analysis by The Washington Post, which followed a tweet by Clinton claiming, "I had zero emails that were classified", also quotes the same 2019 State Department report as having noted, "None of the emails at issue in this review were marked as classified."

Prior to running, Clinton served as the United States secretary of state in the administration of Barack Obama from 2009 to 2013, a U.S. senator representing New York from 2001 to 2009, and the first lady of the United States, as the wife of Bill Clinton, from 1993 to 2001. She was defeated in the general election by the Republican candidate, businessman Donald Trump.

Clinton announced her candidacy on April 12, 2015. Her main competitor in the Democratic primaries was Vermont Senator Bernie Sanders, who ran as a more progressive candidate in the primary. Clinton became the presumptive nominee of the Democratic Party on June 6, 2016, having received the required number of delegates. On July 22, she announced Virginia Senator Tim Kaine as her running mate, and the two were formally nominated at the 2016 Democratic National Convention on July 26.

Clinton received the most support from middle aged and older voters, as well as from African-American, Latino, and older female voters. She focused her platform on several issues, including expanding racial, LGBTQ, and women's rights; raising wages and ensuring equal pay for women; and improving healthcare.

Clinton lost the general election to Republican Donald Trump on November 9, 2016; she conceded the following day. Clinton's narrow, unprecedented losses in the blue wall states of Michigan, Pennsylvania, and Wisconsin were considered key to her defeat. Had Clinton been elected, she would have been the first female and first spouse of a president to serve as president of the United States, whereas her daughter, Chelsea Clinton, would also have been the first acting first lady since Margaret Woodrow Wilson.

### Hillary Clinton 2008 presidential campaign

Clinton was previously the first lady of the United States and first lady of Arkansas prior to her election as U.S. Senator from New York. She is also the wife of former President Bill Clinton. Clinton was the source of much media speculation since having expressed interest in being a candidate in the 2008 presidential election since at least October 2002.

Following her announcement of an exploratory committee and candidacy filing on January 20, 2007, with the FEC, she began fundraising and campaigning activities. For several months Clinton led opinion polls among Democratic candidates by substantial margins until Senator Barack Obama pulled close to or even with her. Clinton then regained her polling lead, winning many polls by double digits; by autumn 2007 she was leading all other Democratic candidates by wide margins in national polls. She placed third in the Iowa caucus behind Barack Obama and John Edwards, and trailed considerably in polls shortly thereafter in New Hampshire before staging a comeback and finishing first in the primary there.

She went on to win a plurality of votes in Nevada, but won fewer delegates in Nevada than Obama, then lost by a large margin in South Carolina. On Super Tuesday, Clinton won the most populous states, including California and New York, while Obama won more states total. The two earned a nearly equal number of delegates and a nearly equal share of the total popular vote. Clinton then lost the next 12 caucuses and primaries to Obama, and lost the overall delegate lead to him for the first time. After an increasingly aggressive round of campaigning, Clinton broke the string of losses with wins in the Rhode Island, and Ohio primaries.

Clinton subsequently lost in Wyoming, Mississippi, Montana, North Carolina and Oregon, and won in Pennsylvania, Indiana, West Virginia, Kentucky, Puerto Rico, and South Dakota. On the final day of primaries on June 3, 2008, Obama had gained enough pledged- and super-delegates to become the presumptive nominee; she then suspended her campaign on June 7, 2008, and endorsed Barack Obama.

While losing the delegate count, and thus the nomination, she earned more popular votes than Barack Obama (though unlike Clinton's name, Obama's name wasn't on the ballot in the 2008 Michigan Democratic primary; had all of the "Uncommitted" votes in the Michigan primary been counted as votes for Obama, Obama would have very narrowly won the popular vote as well). In the general election, Barack Obama defeated Senator and Republican nominee John McCain of Arizona, and nominated Clinton as the 67th Secretary of State, an

office in which she served until February 2013.

In the 2016 presidential election, Clinton would go on to become the Democratic presidential nominee, but was defeated by Republican nominee Donald Trump, who endorsed her in the 2008 primaries.

### Political positions of Hillary Clinton

In accordance with longstanding custom, during her time as Secretary of State she largely avoided taking stances on most domestic political issues. In 2015, she announced her candidacy for the presidency. Clinton won the Democratic primaries defeating Bernie Sanders and formally became the party's nominee at the 2016 Democratic National Convention. She lost the 2016 US presidential election to billionaire real estate mogul and Republican nominee Donald Trump.

Over her career, Clinton has developed a reputation as a "policy wonk" who frequently consults with expert advisors and is deeply involved in the details of policy proposals. By August 2016, the Clinton campaign had released 38 policy proposals and 65 fact-sheets, totaling 112,735 words.

### Clinton body count conspiracy theory

The Congressional Record (1994) stated that the compiler of the original list, Linda Thompson, admitted she had "no direct evidence" of Clinton killing anyone. Indeed, she claimed the deaths were probably caused by "people trying to control the president" but refused to say who they were.

Such allegations have been circulated since at least 1994, when a film called *The Clinton Chronicles*, produced by Larry Nichols and promoted by Rev. Jerry Falwell, accused Bill Clinton of multiple crimes, including murder. Additional promulgators of the conspiracy include Christopher Ruddy, Donald Trump, and Marjorie Taylor Greene.

Several sources have discredited the conspiracy theory, such as the Congressional Record, the Lakeland Ledger, the Chicago Tribune, Snopes and others, pointing to detailed death records, the unusually large circle of associates that a president is likely to have, and the fact that many of the people listed had been misidentified or were still alive. Others had no known link to the Clintons.
