Saccharomyces cerevisiae

vitamins. *Saccharomyces cerevisiae* is grown in selenium-rich media to produce a yeast rich in organic selenium compounds that can be more easily absorbed - *Saccharomyces cerevisiae* () (brewer's yeast or baker's yeast) is a species of yeast (single-celled fungal microorganisms). The species has been instrumental in winemaking, baking, and brewing since ancient times. It is believed to have been originally isolated from the skin of grapes. It is one of the most intensively studied eukaryotic model organisms in molecular and cell biology, much like *Escherichia coli* as the model bacterium. It is the microorganism which causes many common types of fermentation. *S. cerevisiae* cells are round to ovoid, 5–10 µm in diameter. It reproduces by budding.

Many proteins important in human biology were first discovered by studying their homologs in yeast; these proteins include cell cycle proteins, signaling proteins, and protein-processing enzymes. *S. cerevisiae* is currently the only yeast cell known to have Berkeley bodies present, which are involved in particular secretory pathways. Antibodies against *S. cerevisiae* are found in 60–70% of patients with Crohn's disease and 10–15% of patients with ulcerative colitis, and may be useful as part of a panel of serological markers in differentiating between inflammatory bowel diseases (e.g. between ulcerative colitis and Crohn's disease), their localization and severity.

Economy of Germany

In 2019, the country was the world's 3rd largest producer of selenium, the world's 5th largest producer of potash - The economy of Germany is a highly developed social market economy. It has the largest national economy in Europe, the third-largest by nominal GDP in the world, and the sixth-largest by PPP-adjusted GDP. Due to a volatile currency exchange rate, Germany's GDP as measured in dollars fluctuates sharply, but it is among the world's top 4 since 1960. In 2025, the country accounted for 23.7% of the Euro area economy according to the International Monetary Fund (IMF). Germany is a founding member of the European Union and the eurozone.

Germany is the third-largest exporter globally with \$1.66 trillion worth of goods and services exported in 2024. In 2024, Germany recorded a trade surplus worth \$255 billion, ranking 2nd worldwide. The service sector contributes around 70% of the total GDP, industry 29.1%, and agriculture 0.9%. Exports accounted for 50.3% of national output. The top 10 exports of Germany are vehicles, machinery, chemical goods, electronic products, electrical equipment, pharmaceuticals, transport equipment, basic metals, food products, and rubber and plastics. Germany is the largest manufacturing economy in Europe, contributing around one third of all manufacturing in Europe, which makes it more resilient to global economic crises. Germany conducts applied research with practical industrial value and sees itself as a bridge between the latest university insights and industry-specific product and process improvements. It generates a great deal of knowledge in its own laboratories. Among OECD members, Germany has a highly efficient and strong social security system, which comprises roughly 25% of GDP.

Germany is rich in timber, lignite, potash, and salt. Some minor sources of natural gas are being exploited in the state of Lower Saxony. Until German reunification, the German Democratic Republic mined for uranium in the Ore Mountains (see also: SAG/SDAG Wismut). Energy in Germany is sourced predominantly by fossil fuels (30%), with wind power in second place, then gas, solar, biomass (wood and biofuels), and hydro. Germany is the first major industrialised nation to commit to the renewable energy transition called Energiewende. Renewables produced 46% of electricity consumed in Germany (as of 2019). Germany has

been called "the world's first major renewable energy economy". Germany has the world's second-largest gold reserve, with over 3,000 tonnes of gold. As of 2023, Germany spends around 3.1% of GDP, third among major economies, on research and development. It is also the world's second-largest high-technology exporter and ranks in the top 10 of countries by stock market capitalization.

More than 99 percent of all German companies belong to the German "Mittelstand", small and medium-sized enterprises, which are mostly family-owned. These companies represent 48% of the global market leaders in their segments, labelled hidden champions. Of the world's 500 largest publicly listed companies measured by revenue, the Fortune Global 500, 29 are headquartered in Germany, as are 26 of Europe's 100 largest. Germany is home to many financial centres and economically important cities, such as Berlin, Hamburg, Munich, Cologne, Frankfurt, and Stuttgart. Four German banks are among the biggest in the world. Germany is the world's top location for trade fairs; around two thirds of the world's leading trade fairs take place in Germany. Some of the largest international trade fairs and congresses are held in several German cities such as Hanover, Frankfurt, Cologne, Leipzig, and Düsseldorf.

In some species, the valves are highly calcified, and many are somewhat irregular in shape. Many, but not all oysters, are in the superfamily Ostreoidea.

Some species of oyster are commonly consumed and are regarded as a delicacy in some localities. Some types of pearl oysters are harvested for the pearl produced within the mantle. Others, such as the translucent windowpane oysters, are harvested for their shells.

Cat food

Many minerals only present in minute amounts in the body, including selenium, copper, and molybdenum, act as helpers in a wide variety of enzymatic reactions - Cat food is food specifically formulated and designed for consumption by cats. During the 19th and early 20th centuries, cats in London were often fed horse meat sold by traders known as Cats' Meat Men or Women, who traveled designated routes serving households. The idea of specialized cat food came later than dog food, as cats were believed to be self-sufficient hunters. French writers in the 1800s criticized this notion, arguing that well-fed cats were more effective hunters. By the late 19th century, commercial cat food emerged, with companies like Spratt's producing ready-made products to replace boiled horse meat. Cats, as obligate carnivores, require animal protein for essential nutrients like taurine and arginine, which they cannot synthesize from plant-based sources.

Modern cat food is available in various forms, including dry kibble, wet canned food, raw diets, and specialized formulations for different health conditions. Regulations, such as those set by the Association of American Feed Control Officials (AAFCO), ensure that commercially available foods meet specific nutritional standards. Specialized diets cater to cats with conditions like chronic kidney disease, obesity, and gastrointestinal disorders, adjusting protein, fat, and fiber levels accordingly. Weight control diets often include fiber to promote satiety, while high-energy diets are formulated for kittens, pregnant cats, and recovering felines.

Alternative diets, such as grain-free, vegetarian, and raw food, have gained popularity, though they remain controversial. Grain-free diets replace traditional carbohydrates with ingredients like potatoes and peas but do not necessarily have lower carbohydrate content. Vegan and vegetarian diets pose significant health risks due

to cats' inability to synthesize essential nutrients found in animal proteins. Raw feeding mimics a natural prey diet but carries risks of bacterial contamination and nutritional imbalances. The pet food industry also has environmental implications, as high meat consumption increases pressure on livestock farming and fish stocks.

Nutritionally, cats require proteins, essential fatty acids, vitamins, and minerals to maintain their health. Deficiencies in nutrients like taurine, vitamin A, or arginine can lead to severe health problems. The inclusion of probiotics, fiber, and antioxidants supports digestive health, while certain vitamins like E and C help counteract oxidative stress. The pet food industry continues to evolve, balancing nutrition, sustainability, and consumer preferences while addressing emerging health concerns related to commercial diets.

Meat

tissue is high in protein, containing all of the essential amino acids, and in most cases is a good source of zinc, vitamin B12, selenium, phosphorus, niacin - Meat is animal tissue, mostly muscle, that is eaten as food. Humans have hunted and farmed other animals for meat since prehistory. The Neolithic Revolution allowed the domestication of vertebrates, including chickens, sheep, goats, pigs, horses, and cattle, starting around 11,000 years ago. Since then, selective breeding has enabled farmers to produce meat with the qualities desired by producers and consumers.

Meat is mainly composed of water, protein, and fat. Its quality is affected by many factors, including the genetics, health, and nutritional status of the animal involved. Without preservation, bacteria and fungi decompose and spoil unprocessed meat within hours or days. Meat is edible raw, but it is mostly eaten cooked, such as by stewing or roasting, or processed, such as by smoking or salting.

The consumption of meat (especially red and processed meat, as opposed to fish and poultry) increases the risk of certain negative health outcomes including cancer, coronary heart disease, and diabetes. Meat production is a major contributor to environmental issues including global warming, pollution, and biodiversity loss, at local and global scales, but meat is important to economies and cultures around the world. Some people (vegetarians and vegans) choose not to eat meat for ethical, environmental, health or religious reasons.

Beef

There are various other recipes for pickled beef. Sauerbraten is a German variant. Beef is the third most widely consumed meat in the world, accounting - Beef is the culinary name for meat from cattle (*Bos taurus*). Beef can be prepared in various ways; cuts are often used for steak, which can be cooked to varying degrees of doneness, while trimmings are often ground or minced, as found in most hamburgers. Beef contains protein, iron, and vitamin B12. Along with other kinds of red meat, high consumption is associated with an increased risk of colorectal cancer and coronary heart disease, especially when processed. Beef has a high environmental impact, being a primary driver of deforestation with the highest greenhouse gas emissions of any agricultural product.

In prehistoric times, humans hunted aurochs and later domesticated them. Since that time, numerous breeds of cattle have been bred specifically for the quality or quantity of their meat. Today, beef is the third most widely consumed meat in the world, after pork and poultry. As of 2018, the United States, Brazil, and China were the largest producers of beef.

Some religions and cultures prohibit beef consumption, especially Indian religions like Hinduism. Buddhists are also against animal slaughtering, but they do not have a wrongful eating doctrine.

Timeline of United States inventions (before 1890)

Fritts in 1883, who used junctions formed by coating selenium with an extremely thin layer of gold. In 1941, the silicon solar cell was invented by another - The United States provided many inventions in the time from the Colonial Period to the Gilded Age, which were achieved by inventors who were either native-born or naturalized citizens of the United States. Copyright protection secures a person's right to his or her first-to-invent claim of the original invention in question, highlighted in Article I, Section 8, Clause 8 of the United States Constitution, which gives the following enumerated power to the United States Congress:

To promote the Progress of Science and useful Arts, by securing for limited Times to Authors and Inventors the exclusive Right to their respective Writings and Discoveries.

In 1641, the first patent in North America was issued to Samuel Winslow by the General Court of Massachusetts for a new method of making salt. On April 10, 1790, President George Washington signed the Patent Act of 1790 (1 Stat. 109) into law proclaiming that patents were to be authorized for "any useful art, manufacture, engine, machine, or device, or any improvement therein not before known or used". On July 31, 1790, Samuel Hopkins of Pittsford, Vermont became the first person in the United States to file and to be granted a patent for an improved method of "Making Pot and Pearl Ashes". The Patent Act of 1836 (Ch. 357, 5 Stat. 117) further clarified United States patent law to the extent of establishing a patent office where patent applications are filed, processed, and granted, contingent upon the language and scope of the claimant's invention, for a patent term of 14 years with an extension of up to an additional 7 years. However, the Uruguay Round Agreements Act of 1994 (URAA) changed the patent term in the United States to a total of 20 years, effective for patent applications filed on or after June 8, 1995, thus bringing United States patent law further into conformity with international patent law. The modern-day provisions of the law applied to inventions are laid out in Title 35 of the United States Code (Ch. 950, sec. 1, 66 Stat. 792).

From 1836 to 2011, the United States Patent and Trademark Office (USPTO) has granted a total of 7,861,317 patents relating to several well-known inventions appearing throughout the timeline below.
