Risk assessment

Risk assessment is a process for identifying hazards, potential (future) events which may negatively impact on individuals, assets, and/or the environment - Risk assessment is a process for identifying hazards, potential (future) events which may negatively impact on individuals, assets, and/or the environment because of those hazards, their likelihood and consequences, and actions which can mitigate these effects. The output from such a process may also be called a risk assessment. Hazard analysis forms the first stage of a risk assessment process. Judgments "on the tolerability of the risk on the basis of a risk analysis" (i.e. risk evaluation) also form part of the process. The results of a risk assessment process may be expressed in a quantitative or qualitative fashion.

Risk assessment forms a key part of a broader risk management strategy to help reduce any potential risk-related consequences.

MBA programs in the United States typically require completing about forty to sixty semester credit hours,

much higher than the thirty semester credit hours typically required for other US master's degrees that cover some of the same material. The UK-based Association of MBAs accreditation requires "the equivalent of at least 1,800 hours of learning effort", equivalent to 45 US semester credit hours or 90 European ECTS credits, the same as a standard UK master's degree. Accreditation bodies for business schools and MBA programs ensure consistency and quality of education. Business schools in many countries offer programs tailored to full-time, part-time, executive (abridged coursework typically occurring on nights or weekends) and distance learning students, many with specialized concentrations.

An "Executive MBA", or EMBA, is a degree program similar to an MBA program that is specifically structured for and targeted towards corporate executives and senior managers who are already in the workforce.

Master craftsman

Apollo 7

Apollo 7 (October 11–22, 1968) was the first crewed flight in NASA's Apollo program, and saw the resumption of human spaceflight by the agency after the - Apollo 7 (October 11–22, 1968) was the first crewed flight in NASA's Apollo program, and saw the resumption of human spaceflight by the agency after the fire that had killed the three Apollo 1 astronauts during a launch rehearsal test on January 27, 1967. The Apollo 7 crew was commanded by Walter M. Schirra, with Command Module Pilot Donn F. Eisele and Lunar Module pilot R. Walter Cunningham (so designated even though Apollo 7 did not carry a Lunar Module).

The three astronauts were originally designated for the second crewed Apollo flight, and then as backups for Apollo 1. After the Apollo 1 fire, crewed flights were suspended while the cause of the accident was investigated and improvements made to the spacecraft and safety procedures, and uncrewed test flights made. Determined to prevent a repetition of the fire, the crew spent long periods monitoring the construction of their Apollo command and service modules (CSM). Training continued over much of the 21-month pause that followed the Apollo 1 disaster.

Apollo 7 was launched on October 11, 1968, from Cape Kennedy Air Force Station, Florida, and splashed down in the Atlantic Ocean eleven days later. Extensive testing of the CSM took place, and also the first live television broadcast from an American spacecraft. Despite tension between the crew and ground controllers, the mission was a complete technical success, giving NASA the confidence to send Apollo 8 into orbit around the Moon two months later. In part because of these tensions, none of the crew flew in space again, though Schirra had already announced he would retire from NASA after the flight. Apollo 7 fulfilled Apollo 1's mission of testing the CSM in low Earth orbit, and was a significant step towards NASA's goal of landing astronauts on the Moon.

MasterFormat

ASTM standard for sustainability assessment of building products relies on MasterFormat to organize the data. MasterFormat is an organizational component - MasterFormat is a standard for organizing specifications and other written information for commercial and institutional building projects in the U.S. and Canada. Sometimes referred to as the "Dewey Decimal System" of building construction, MasterFormat is a product of the Construction Specifications Institute (CSI) and Construction Specifications Canada (CSC). It provides a master list of Divisions, and Section numbers with associated titles within each Division, to organize information about a facility's construction requirements and associated activities.

MasterFormat is used throughout the construction industry to format specifications for construction contract documents. The purpose of this format is to assist the user in organizing information into distinct groups when creating contract documents, and to assist the user searching for specific information in consistent locations. The information contained in MasterFormat is organized in a standardized outline format within 50 Divisions (16 Divisions pre-2004). Each Division is subdivided into a number of Sections.

Climate change

H - Present-day climate change includes both global warming—the ongoing increase in global average temperature—and its wider effects on Earth's climate system. Climate change in a broader sense also includes previous long-term changes to Earth's climate. The current rise in global temperatures is driven by human activities, especially fossil fuel burning since the Industrial Revolution. Fossil fuel use, deforestation, and some agricultural and industrial practices release greenhouse gases. These gases absorb some of the heat that the Earth radiates after it warms from sunlight, warming the lower atmosphere. Carbon dioxide, the primary gas driving global warming, has increased in concentration by about 50% since the pre-industrial era to levels not seen for millions of years.

Climate change has an increasingly large impact on the environment. Deserts are expanding, while heat waves and wildfires are becoming more common. Amplified warming in the Arctic has contributed to thawing permafrost, retreat of glaciers and sea ice decline. Higher temperatures are also causing more intense storms, droughts, and other weather extremes. Rapid environmental change in mountains, coral reefs, and the Arctic is forcing many species to relocate or become extinct. Even if efforts to minimize future warming are successful, some effects will continue for centuries. These include ocean heating, ocean acidification and sea level rise.

Climate change threatens people with increased flooding, extreme heat, increased food and water scarcity, more disease, and economic loss. Human migration and conflict can also be a result. The World Health Organization calls climate change one of the biggest threats to global health in the 21st century. Societies and ecosystems will experience more severe risks without action to limit warming. Adapting to climate change through efforts like flood control measures or drought-resistant crops partially reduces climate change risks, although some limits to adaptation have already been reached. Poorer communities are responsible for a small share of global emissions, yet have the least ability to adapt and are most vulnerable to climate change.

Many climate change impacts have been observed in the first decades of the 21st century, with 2024 the warmest on record at +1.60 °C (2.88 °F) since regular tracking began in 1850. Additional warming will increase these impacts and can trigger tipping points, such as melting all of the Greenland ice sheet. Under the 2015 Paris Agreement, nations collectively agreed to keep warming "well under 2 °C". However, with pledges made under the Agreement, global warming would still reach about 2.8 °C (5.0 °F) by the end of the century. Limiting warming to 1.5 °C would require halving emissions by 2030 and achieving net-zero emissions by 2050.

There is widespread support for climate action worldwide. Fossil fuels can be phased out by stopping subsidising them, conserving energy and switching to energy sources that do not produce significant carbon pollution. These energy sources include wind, solar, hydro, and nuclear power. Cleanly generated electricity can replace fossil fuels for powering transportation, heating buildings, and running industrial processes. Carbon can also be removed from the atmosphere, for instance by increasing forest cover and farming with methods that store carbon in soil.

New York City

The city and its metropolitan area are the premier gateway for legal immigration to the United States. An estimated 800 languages are spoken in New York City, making it the most linguistically diverse city in the world. The New York City metropolitan region is home to the largest foreign-born population of any metropolitan region in the world, approximately 5.9 million as of 2023.

New York City traces its origins to Fort Amsterdam and a trading post founded on Manhattan Island by Dutch colonists around 1624. The settlement was named New Amsterdam in 1626 and was chartered as a city in 1653. The city came under English control in 1664 and was temporarily renamed New York after King Charles II granted the lands to his brother, the Duke of York, before being permanently renamed New York in 1674. Following independence from Great Britain, the city was the national capital of the United States from 1785 until 1790. The modern city was formed by the 1898 consolidation of its five boroughs: Manhattan, Brooklyn, Queens, the Bronx, and Staten Island.

Anchored by Wall Street in the Financial District, Manhattan, New York City has been called both the world's premier financial and fintech center and the most economically powerful city in the world. As of 2022, the New York metropolitan area is the largest metropolitan economy in the world, with a gross metropolitan product of over US\$2.16 trillion. The New York metropolitan area's economy is larger than all but nine countries. Despite having a 24/7 rapid transit system, New York also leads the world in urban automobile traffic congestion. The city is home to the world's two largest stock exchanges by market capitalization of their listed companies: the New York Stock Exchange and Nasdaq. New York City is an established haven for global investors. As of 2025, New York City is the most expensive city in the world for expatriates and has by a wide margin the highest residential rents of any city in the nation. Fifth Avenue is the most expensive shopping street in the world. New York City is home to the highest number of billionaires, individuals of ultra-high net worth (greater than US\$30 million), and millionaires of any city in the world by a significant margin.

These characterizations were made in the context of educating the public about questionable or potentially fraudulent or dangerous claims and practices, efforts to define the nature of science, or humorous parodies of poor scientific reasoning.

Criticism of pseudoscience, generally by the scientific community or skeptical organizations, involves critiques of the logical, methodological, or rhetorical bases of the topic in question. Though some of the listed topics continue to be investigated scientifically, others were only subject to scientific research in the past and today are considered refuted, but resurrected in a pseudoscientific fashion. Other ideas presented here are entirely non-scientific, but have in one way or another impinged on scientific domains or practices.

Many adherents or practitioners of the topics listed here dispute their characterization as pseudoscience. Each section here summarizes the alleged pseudoscientific aspects of that topic.

Vladimir Putin

concluded: There is uncertainty on the precise sum of Putin's wealth, and the assessment by the Director of U.S. National Intelligence apparently is not yet complete - Vladimir Vladimirovich Putin (born 7 October 1952) is a Russian politician and former intelligence officer who has served as President of Russia since 2012, having previously served from 2000 to 2008. Putin also served as Prime Minister of Russia from 1999 to 2000 and again from 2008 to 2012.

Putin worked as a KGB foreign intelligence officer for 16 years, rising to the rank of lieutenant colonel. He resigned in 1991 to begin a political career in Saint Petersburg. In 1996, he moved to Moscow to join the administration of President Boris Yeltsin. He briefly served as the director of the Federal Security Service (FSB) and then as secretary of the Security Council of Russia before being appointed prime minister in August 1999. Following Yeltsin's resignation, Putin became acting president and, less than four months later in May 2000, was elected to his first term as president. He was reelected in 2004. Due to constitutional limitations of two consecutive presidential terms, Putin served as prime minister again from 2008 to 2012 under Dmitry Medvedev. He returned to the presidency in 2012, following an election marked by allegations of fraud and protests, and was reelected in 2018.

During Putin's initial presidential tenure, the Russian economy grew on average by seven percent per year as a result of economic reforms and a fivefold increase in the price of oil and gas. Additionally, Putin led Russia in a conflict against Chechen separatists, re-establishing federal control over the region. While serving as prime minister under Medvedev, he oversaw a military conflict with Georgia and enacted military and police reforms. In his third presidential term, Russia annexed Crimea and supported a war in eastern Ukraine through several military incursions, resulting in international sanctions and a financial crisis in Russia. He also ordered a military intervention in Syria to support his ally Bashar al-Assad during the Syrian civil war, with the aim of obtaining naval bases in the Eastern Mediterranean.

In February 2022, during his fourth presidential term, Putin launched a full-scale invasion of Ukraine, which prompted international condemnation and led to expanded sanctions. In September 2022, he announced a partial mobilization and forcibly annexed four Ukrainian oblasts into Russia. In March 2023, the International Criminal Court issued an arrest warrant for Putin for war crimes related to his alleged criminal responsibility for illegal child abductions during the war. In April 2021, after a referendum, he signed constitutional amendments into law that included one allowing him to run for reelection twice more, potentially extending his presidency to 2036. In March 2024, he was reelected to another term.

Under Putin's rule, the Russian political system has been transformed into an authoritarian dictatorship with a personality cult. His rule has been marked by endemic corruption and widespread human rights violations, including the imprisonment and suppression of political opponents, intimidation and censorship of independent media in Russia, and a lack of free and fair elections. Russia has consistently received very low scores on Transparency International's Corruption Perceptions Index, The Economist Democracy Index,

Freedom House's Freedom in the World index, and the Reporters Without Borders' World Press Freedom Index.
